### Exhibitor Q&A

### What precautions are you putting in place to tackle the current COVID-19 outbreak?

Ensuring the safety and wellbeing of all visitors to ASEAN Super 8 is our primary concern. Please refer to our precautionary measurement at the event. You may refer the file as attached.

The venue, Malaysia International Trade and Exhibition Centre (MITEC) remains open and events are taking place as planned. We continue to liaise closely with and follow advice from MITEC which is based on the latest information from the Ministry of Health Malaysia

All hand sanitisers are available at the main entrance and within the dedicated locations within the venue.

The cleaning teams at the MITEC are also focusing on any areas where the virus could be more likely to spread including:

- Hard surfaces: registration and information desks and toilets
- Control pads: lifts
- Door handles: main entrances, hall floor entrances, meeting rooms, escalators and toilet entrances, as well as exit push buttons
- Handrails, cafeteria and common areas



#### Will there be exhibitors from countries affected by the COVID-19 at the event?

We have been closely communicating with exhibitors who are unable to travel, or have been advised not to, for public health reasons. These exhibitors will have a digital presence online via mobile apps at this year's event and we look forward to welcoming them in future years.

Exhibitors who are from countries where there are no travel restrictions in place will appear at the event as planned.

#### Will ASEAN Super 8 2020 be going ahead as planned?

ASEAN Super 8 will be rescheduled from 20 – 22 October 2020, and it will be held in Malaysia International Trade and Exhibition Centre (MITEC).

The decision to postpone ASEAN Super 8, which was originally scheduled from 23 to 25 June 2020, is taken with regret after careful consideration and close consultations with the key stakeholders, exhibitors and industry partners due to recent and increasing travel restrictions impacting industry participation and new travel measures enacted by the Malaysia government in light of the COVID-19 situation.

# Are you expecting a drop in visitor numbers due to the concerns around the spread of the COVID-19?

Our visitor registrations are ahead of year-on-year figures and visitor numbers from affected countries are relatively low; therefore, we do not expect the COVID-19 to have a negative impact on the event. We are looking forward to welcoming thousands of visitors and over 450 brands to ASEAN Super 8 2020 and we are confident it will be a fantastic event for everyone involved.

#### Who should I contact if I have concerns during the event?

If you start to feel unwell while visiting ASEAN Super 8 2020, please consult our medical expert at dedicated locations located at North Entrance and South Entrance, Level 1. The onsite team is fully briefed and has plans in place to deal with anyone experiencing symptoms of COVID-19. This includes separate areas to isolate people until they can be taken to hospital.
